## **Understanding ITIN**

What is an ITIN? An Individual Taxpayer Identification Number is a tax processing number issued by the IRS.

Why Do I Need It? It's required for individuals who need a U.S. taxpayer identification number but are not eligible to obtain a Social Security Number.

Who Qualifies for One? Non-U.S. residents, resident aliens, and their dependents or spouses can apply.

Why Did I Receive a Response Letter? Occasionally, the IRS requests further verification of identity, which might be a signature confirmation.

# **Application Requirements**

For Individuals: Income report, tax return, date of entry (if residing in the U.S.), color copy of your signed passport, U.S. mailing address (no P.O. boxes), and total foreign address.

**For Business Exceptions:** LLC or Corp documents, EIN letter, color copy of passport, U.S. mailing address (no P.O. boxes), and foreign address.

#### **Minor Applications**

Please find below the required documents that need to be submitted for a minor to be listed in the 1040 form:

- A color scan copy of the passport

- A copy of the birth certificate, which doesn't require translation

- Proof of residency, a letterhead from the school signed with blue ink. The letter must mention the minor's name, date of birth, address, and school grade. Alternatively, a letter from a doctor with the same guidelines can also be submitted.
